Leisure Involvement For Everyone (LIFE) assists individuals and families with low incomes to access recreation services and programs at all municipal recreation centres in Greater Victoria.

- Who Is Eligible?**
- Residents of Colwood, Langford, Highlands, Metchosin and View Royal whose gross income is under the Low Income Thresholds outlined below.
 - Proof of gross income for all adults and/or combined income for married/common-law partners is required.

- How Do I Apply?**
- Complete one application per family and drop off at reception at the Juan de Fuca Recreation Centre, 1767 Island Highway, Victoria BC, or call 250-478-8384 with any questions.
 - Bring current proof of residency with you, such as a utility bill, rental agreement or government ID.
 - Provide 2024 or 2025 Notice of Assessment. A copy may be obtained through Revenue Canada at 1-800-959-8281 or <http://www.cra-arc.gc.ca/myaccount>.
 - Newcomers (immigrated to Canada within the last 5 years and establishing residency) may provide official travel documents for each family member instead of an NOA for their first year as a LIFE member.

When applying for the LIFE Program, please provide the following:

- 1a. Current Canada Revenue NOA (Notice of Assessment) listing line 15000 as it appears on the assessment.
- OR
- 1b. Official travel documents for each family member if applying as a newcomer.
2. Proof of current residency (i.e., valid Driver's License or BCID, recent hydro or other bill showing address)

PASS DETAILS

- 52 WSPR drop-in admissions provide access to golf, swim, skate, weightroom, and select drop-in fitness programs per calendar year at West Shore Parks & Recreation.
- 52 regional drop-in admissions are per calendar year at any Greater Victoria Recreation Centre in Saanich, City of Victoria, Oak Bay, Panorama, Esquimalt and SEAPARC.
- Membership/registration discounts are per calendar year. Choose from any of the following using their discount option:
 - 50% off (up to \$50) West Shore Parks & Recreation registered programs.
 - 50% off (up to \$50) West Shore Parks & Recreation 10x, 25x general visit or specialty visit passes, and golf punch passes.
 - 50% off West Shore Parks & Recreation 1-month, 3-month, and annual Greater Victoria Regional Recreation Pass expire based on date of purchase. WSPR continuous membership expires December 31, 2026.
- Juan de Fuca 55+ Activity Centre annual membership expires August 31, 2026.

TERMS and OTHER INFORMATION

Terms:

- Some restrictions apply.
- LIFE card must be presented at the time of admission.
- LIFE members must have their picture taken for their LIFE card.
- LIFE passes are non-transferable, and are not eligible for cash or credit.

Other Information:

- WSPR LIFE members may book a free JDF weightroom orientation through reception.
- Monthly payment plans are available for continuous memberships and regional annual passes; Visa/MasterCard/AMEX and automatic debit from your chequing account are accepted.
- One LIFE card will be issued once per year to each member of an eligible family and are valid for one calendar year (January 1 to December 31, 2026).
- \$5 + tax replacement charge for lost cards. All replacement cards will have 4 visits per month marked off from January up to the date the card is replaced.

SELF DECLARATION and CONSENT

LIFE passes will be cancelled if submitted information is discovered to be false. Random checks are done and LIFE members will be asked to verify revenue based on Revenue Canada's most recent tax return. It is a serious offence to provide inaccurate information on this form.
